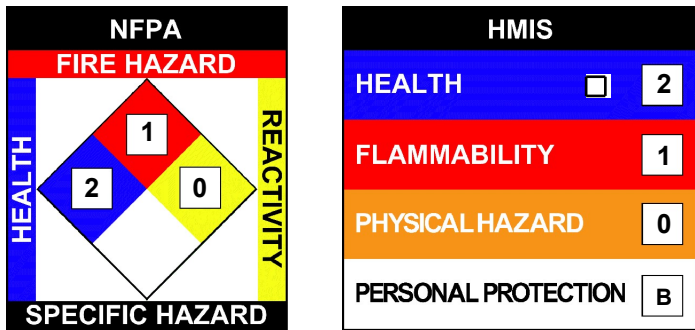

4 FIRST AID MEASURES

Inhalation: Remove from exposure and get fresh air. Keep warm and at rest. Get medical attention immediately if artificial respiration is required.

5 FIRE FIGHTING MEASURES
